 - 1. State of Michigan has a program to spur growth in the economy:
 - A. State Develop Zones, in that zone for every \$200,000 spent the State grants one liquor license.
 - B. State approves the license
 - C. Owner buys the license, after completing all licensing steps.

- D. Township controls the license, Township decides who will get the license and how that license will stimulate growth and fit into the area.
- E. Downtown Development Authority (DDA) needs a board; Township our size can use the Planning Commission as the Board.
- F. 55% of the money from the license goes to the Township general fund to spend as needed.
- G. Once license is obtained it is not portable, it goes back to the Township.
