The regular meeting of the Golden Township Board was called to order by Chairman, Carl Fuehring, at 7:30 p.m. in the Golden Township Hall. The Pledge of Allegiance was recited.

Public Comment:

- -Linda Chapman asked if the Christmas Tree Lighting at the Golden Township Park at Silver Lake Sand Dunes could still go forward as far as the township was concerned if the residents could pull it together as those who usually do this are not going to this year. The township gave approval as long as it doesn't require township funding.

The Treasurer read the Financial Report. The ending balance in the Fund as of November 13, 2018 was as follows: General Fund \$37,117.42; Road fund \$65,101.34; Fire Fund \$2,282.11; Park/Recreation Cash Fund \$1,162.47. Note: Money from some accounts have been put in an investment Fund to earn interest and it has acquired \$145.50 since 10-16-2018.

Bills: Motion by Mr. Walsworth, supported by Mr. Beggs to pay check numbers 17628 through 17676, and EFT 104 & 105 in the general fund for the amount of \$69,556.78. Roll call vote all yes, the motion carried.

Zoning Report: There were 96 permits this year. Approximately 30 Rental violations are going out as well as some zoning violations. The board is adamant, upon the advice of their attorney, that all fines will be enforced.

At the last board meeting Land Teck/Shore Teck was approved to give a letter of support for putting sand in to recapture land washed away on Lake Michigan.
