Scott Goyings Land Division: Motion by Mr. Walsworth, supported by Mrs. Cargill, to approve the Goyings land division parcel # 64-006-021-100-11. All yes, the motion carried.

Richard Walsworth Land Division: Motion by Mrs. Cargill, supported by Mrs. Iteen, to approve the land division parcel # 64-006-010-200-05. Dick Walsworth abstained from voting on this land division, all yes, the motion carried. See attached papers for land divisions.

Park Report:

Golden Township Park at Silver Lake Sand Dunes: Mrs. Cargill mentioned that the township will apply for the acquisition grant and the Department of Natural Resources Development Grant next spring and that the Recreation Plan has be current to apply.

Fire Report: The fire chief has started the process to fill the position of two captains, and later the position of two lieutenants. The chief is community minded and has involved the fire department in community activities.

Planning Commission: There was a public hearing for Wilson's for a car wash and a rec room. Nothing approved as the required paper work has not been turned in.

Road Report: Mr. Walsworth stated that the road across the Upper Silver Lake Dam spillway is open now and the road stripping is being done as well. The road committee will be reviewing the roads to put together a plan for next year's road repairs.

Zoning Minutes Professionally Transcribed: Mr. Draper thought that the person applying for the variance should pay for the cost of transcribing and Mr. Walsworth agreed. Connie will look into fees for a person to attend the meeting and transcribe the minutes.

- -Patricia Driscoll commented on her letter read during correspondence concerning camping on her land that she has owned for 26 years.
- -Amy Zaloga, an Applefest committee member, stated that she received several complements about the festival and that the attendees would like the park to remain simple and would not want additional asphalt to change the atmosphere of the park.
- -Mrs. Cargill mentioned it would be a good thing for the board to attend the MTA regional meeting coming to Ludington's Lincoln Hills Golf Course in October.

The meeting was adjourned and then re-convened.
