Pursuant to provisions of Golden Township Ordinance # 46 as amended by Ordinance # 12 "Outdoor Gathering", (also referred to as "the Ordinance" hereinafter), the following application is required to be completed in its entirety to obtain a permit pursuant to the Ordinance. A completed application, all documents required by the Ordinance and application fee shall be submitted to the Golden Township Clerk at least 60 days prior to the date of the event. Failure to submit all documents required by the Ordinance shall render an application incomplete, and shall result in the return of the application for completion.

14. THE FOLLOWING NOTICE IS GIVEN:

A person shall not sponsor, operate, maintain, conduct, or promote an outdoor assembly in Golden Township unless he shall have first made application for, and obtained, as hereinafter prescribed, a license for such assembly or assemblies. It shall be unlawful for a licensee, his employee, or agent to knowingly: advertise, promote or sell tickets to, conduct or operate an assembly without first obtaining a license as herein provided.

15. The Outdoor Gathering must adhere to all County, State, and Federal Laws, and Township Ordinances. Failure to do so will result in revocation of any issued permits.

As property owner of the property to be used for the proposed Outdoor Gathering, I grant permission for access to the premises for inspection by Golden Township Officials, State and Oceana County Police Officers.
