Resolution No. 2019-12 TOWNSHIP OF GOLDEN COUNTY OF OCEANA, MICHIGAN

#### TOWNSHIP BOARD RESOLUTION TO ADOPT MASTER PLAN

WHEREAS, the Michigan Planning Enabling Act (MPEA) authorizes the Planning Commission to prepare a master plan for the use, development and preservation of all lands in the Township; and

WHEREAS, the Planning Commission prepared a proposed master plan and submitted the plan to the Township Board for review and comment; and

WHEREAS, on June 11, 2019, the Golden Township Board received and reviewed the proposed master plan prepared by the Planning Commission and authorized distribution of the proposed master plan to the Notice Group entities identified in the MPEA; and

WHEREAS, notice was provided to the Notice Group entities as provided in the MPEA; and WHEREAS, the Planning Commission held a public hearing on August 27, 2019 to consider public comment on the proposed master plan, and to further review and comment on the proposed master plan; and

WHEREAS, on October 29, 2019, the Planning Commission approved and adopted by resolution the proposed master plan; and

WHEREAS, the Township Board finds that the proposed master plan, the Golden Township Master Plan is desirable and proper and furthers the use, preservation, and development goals and strategies of the Township;

# THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

- 1. Adoption of the Golden Township Master Plan, 2019 Update. The Township Board hereby approves and adopts the proposed Golden Township Master Plan, 2019 Update, including all of the chapters, figures, maps and tables contained therein.
- 2. *Distribution to Notice Group.* The Township Board approves distribution of the adopted plan to the Notice Group.
- 3. *Findings of Fact*. The Township Board has made the foregoing determination based on a review of existing land uses in the Township, a review of the master plan provisions and maps, input received from the Planning Commission and public hearing, and with the assistance of a professional planning group, and finds that the master plan will accurately reflect and implement the Township's goals and strategies for the use, preservation, and development of lands in Golden Township.
  - 4. Effective Date. The Master Plan shall be effective as of the date of adoption of this resolution.
