**The Treasurer read the Financial Report.** The ending balance in the Fund as of February 09, 2021 was as follows: General Fund \$89,044.13; Road fund \$735.30; Capitol Savings Fund \$316.12. The Michigan Class investment funds for the above funds are as follows: GF \$89,568; RF \$226,591; CSF \$87,611.
